ADMINISTRATIVE CHECKLIST FOR ROTARY CLUB — END OF YEAR DISTRICT 5930

It is the end of another successful District 5930 Rotary year. Here are some things your club need to be doing between now and June 30, 2020.

- Membership: Cleanup Club Central. Delete members that are no longer in the club and add any new members. Complete ideally by end of May or mid-June. Note that whoever you have listed on July 1st is how many you will be billed dues. Also, be sure to update members information if there has been changes.
- Ignite: Update your data on the Ignite program and send to Luis Cavazos to show your accomplishments this year.
- R.I. Goals: Go into My Rotary at rotary.org and input updates on your goals and service projects. If you were unable to complete a service project, delete it from the goals. You have to complete the goals by June 30th in order for your club to get recognition for accomplishments this last year.
- Goals for 2020-2021: Incoming Club Presidents should I put their Goals into My Rotary by June 30th. A budget should be drafted and presented to your Board at your first Board meeting in the new Rotary year.
- Club Officers for 2020-2021: All of your officers for next year should already be input to Club Runner. But, unfortunately, we have 24 clubs that have not completed this requirement. I will send an individual email to the Presidents/PE of each club to remind them and advise that we will have to roll over the officers if they fail to elect new ones. RI requires a minimum of President, PresidentElect, Secretary and Treasurer to be notated in order to be a Rotary Club.
- District Grants: Grants your club received for 2019-2020 should have the final information input to Club Runner and closed by May 31, 2020. Requests for grants for 2020-2021 should be submitted by June 30, 2020.
- District 2019-2020 Awards: Because of the Pandemic issues, the District Exemplary and Rooted in Service Awards date has been extended to June 30, 2020 for completion. A form for each award will be posted on the District website by June 1, 2020. Submission will be July 1.

District Assembly: The yearly assembly will be done virtually this year. We are in the planning stages, so watch for further information on this training. To stay engaged with Rotary please sign up and attend the Zoom meetings for District Conference. The next one is scheduled this Saturday (May 9th) at 8:30 am. You have to register to get the access information and the session is free. Go into Rotary5930.org website to register.

- Meeting Plans for 2020-2021:
- DG Bartnesky installation will be done virtually. More information to follow.
- DG club visits will be held virtually for calendar year 2020 unless something changes and it will be re-evaluated.
- District will not host any in-person meetings/events for calendar year 2020 unless somethings changes and it will be re-evaluated.
- No in-person club meeting or events shall be mandatory for any Rotarian participant who may feel uncomfortable attending because of the Pandemic.
- Clubs are free to decide if they should meet in-person or virtually and are encouraged to follow local health and government regulations.

If you need help in working the virtual meetings, the District has several individuals willing to assist you. You can contact your Assistant Governor or the District Webmaster to help you find an assistant. I am available if you have any questions about this guide.

- 2. BEFORE June 30, 2020, click on "Pay or view your club invoice" to review list of members for RI dues, payment due 7/1/2020. To edit member roster, visit with Club Secretary to update members in ClubRunner or directly with RI.
- 3. BEFORE June 30, 2020, work with your club President to develop a club budget. Under *Resources & reference*, see link to *Budget Worksheet* for a template.
- 4. Under How to Prepare, Click on Learning Center (in blue)

You are now in the Learning Center. Type "treasurer" in the search box, and enter. You should find the "Club Treasurer Basics" learning course.
